- 2. **Sponsor**. This Sweepstakes is sponsored by Patriot PAWS Service Dogs, 254 Ranch Trail, Rockwall, Texas 75032 ("**Sponsor**").
- 3. **Prize Provider**. The prize provider of this Sweepstakes is This Is Hit, Inc. d/b/a BBR Music Group, 1 Music Circle S., Nashville, TN 37203 ("**Prize Provider**").
- 4. **Eligibility**. This Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are 21 years of age or older as of the time of entry. Employees of Sponsor, and their respective affiliates, parent companies, and subsidiaries, as well as Prize Provider(s) and any advertising and promotion agencies (collectively, the "Sweepstakes Entities"), together with the immediate families (spouses, parents, siblings, and children) and those persons living in the same household as such employees (whether or not related), are not eligible to enter or win.
- 5. **Promotion Period**. The Sweepstakes begins on May 19, 2025 on 5:30 a.m. Central Time ("CT") and ends at 11:59 p.m. on June 1, 2025 ("**Promotion Period**"). The computer of Sponsor or Sponsor's designated representative is the official timekeeper for the Sweepstakes.
- 6. **How to Enter**. During the Promotion Period, enter using one or both of the following methods of entry:

<u>Donation to Sponsor</u>. (a) Visit https://patriotpaws.org/hawkeye/, (b) donate any dollar amount, the proceeds of which benefit Patriot PAWS; (c) enter the required contact information; and (d) submit the donation. One donation is one Sweepstakes entry. At the time of donation, you will be required to provide credit card details through the secure link.

Alternate Method of Entry ("AMOE") Without a Donation. To enter the Sweepstakes without making a donation to Sponsor, mail a 3" x 5" postcard with your first and last name, telephone number, zip code/post code/postal code, and email address (for notification purposes only) to Patriot PAWS Service Dogs, Attn: Pet for a Vet Sweepstakes Entry, 254 Ranch Trail, Rockwall, Texas 75032. Mail entries must be postmarked by June 1, 2025 and received by June 5, 2025.

Entrants may be given the opportunity to opt in to receive commercial emails and/or text messages from Sweepstakes Entities during the entry process but are not required to do so. Opting in to receive promotional communications will not increase an entrant's chance of winning.

7. **Limit one (1) entry per person, per entry method, per day**. Each entrant may submit one entry via donation or AMOE each day of the Promotion Period. Multiple donations submitted on the same day will only be counted as one entry. Entries become the property of Sponsor and will not be returned to entrant.

Automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot, or sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. Use of multiple email accounts to enter will result in disqualification. All entries must be received and recorded during the Promotion Period to be eligible for the drawing. Proof of entry submission is not proof of receipt by Sponsor.

- 8. **Identity Disputes**. In the event of a dispute over the identity of an entrant, the authorized accountholder of the email address used in the Sweepstakes entry will be deemed to be the entrant. Sponsor will notify the potential winner via telephone or email at their sole discretion. Notification is deemed to have occurred immediately at the time Sponsor calls or transmits an email. Sponsor will only be required to attempt to leave one voicemail message or send one email. Sponsor reserves the right, but not the obligation, to attempt to contact any winner(s) more than once, in its sole and absolute discretion, and will not be required to attempt to contact winner(s) an equal number of times or in the same manner. Sponsor is not responsible for any change of email address and/or telephone number of any entrant(s) and/or winner(s).

If a potential winner (a) cannot be contacted or does not respond to a notification attempt within seven days of notification, or a Prize notification is returned as undeliverable; (b) does not timely return the Required
