Dogs are selected after careful evaluation to ensure only top quality dogs are placed in the program. Once a dog has been accepted for training, they are taught commands that meet and/or exceed the Assistance Dogs International (ADI) Standards. A service dog becomes certified by passing the ADI public access test before it is matched to a potential disabled veteran. Each veteran is evaluated before acceptance into the program. Once accepted to receive a service dog, the dogs are picked for a veteran through observation, evaluation, and the veteran/dog ability to work as a team. During 2014, there were approximately 70 dogs in the program, and 10 dogs were placed with qualified veterans and certified as ADI service dogs.
