ONCE A DOG HAS BEEN ACCEPTED FOR TRAINING, THEY ARE TAUGHT COMMANDS THAT MEET AND/OR EXCEED THE ASSISTANCE DOGS INTERNATIONAL (ADI) STANDARDS. A SERVICE DOG BECOMES CERTIFIED BY PASSING THE ADI PUBLIC ACCESS TEST BEFORE IT IS MATCHED TO A POTENTIAL DISABLED VETERAN. EACH VETERAN IS EVALUATED BEFORE ACCEPTANCE INTO THE PROGRAM. ONCE ACCEPTED TO RECEIVE A SERVICE DOG, THE DOGS ARE PICKED FOR A VETERAN THROUGH OBSERVATION, EVALUATION, AND THE VETERAN/DOG ABILITY TO WORK AS A TEAM. DURING 2016, THERE WERE 78 DOGS IN THE PROGRAM, 25 OF WHICH WERE CERTIFIED (10 ADI SERVICE DOGS, 14 COMPANION DOGS AND 1 FACILITY DOG). A BOARD MEMBER THAT IS ALSO A VET DONATED HER TIME AS A VET TO PPSD A COUPLE HOURS A WEEK.
