ONCE A DOG HAS BEEN ACCEPTED FOR TRAINING, THEY ARE TAUGHT COMMANDS THAT MEET AND/OR EXCEED THE ASSISTANCE DOGS INTERNATIONAL (ADI) STANDARDS. A SERVICE DOG BECOMES CERTIFIED BY PASSING THE ADI PUBLIC ACCESS TEST BEFORE IT IS MATCHED TO A POTENTIAL DISABLED VETERAN. EACH VETERAN IS EVALUATED BEFORE ACCEPTANCE INTO THE PROGRAM. ONCE ACCEPTED TO RECEIVE A SERVICE DOG, THE DOGS ARE PICKED FOR A VETERAN THROUGH OBSERVATION, EVALUATION, AND THE VETERAN/DOG ABILITY TO WORK AS A TEAM.
